# **Program Overview**

Capital's School of Nursing is committed to developing professional nurses who combine knowledge and hands-on skills with the ability to think critically and make clinical decisions in the fast-paced healthcare environment. A thorough foundation in the liberal arts helps Capital graduates understand and respect the worth and dignity of individual patients and families. Throughout the program, students will engage in laboratory practice within the school's skills laboratories and state-of-theart simulation facilities at both Capital and affiliated healthcare partner institutions.

# **Experiential Learning**

During their studies, students have access to nearly every major healthcare facility in the area. Clinical experience is characterized by a maximum (it's often less!) 1:8 faculty/student ratio and individualized teaching approaches. As seniors, students participate in a clinical practicum and in advanced care simulations. International study abroad and off-campus study programs are available. Participation in these programs provides a unique opportunity to examine different healthcare delivery systems. Capital provides students with a variety of opportunities in nursing research with faculty as mentors. (Note: This occurs less frequently than the other activities mentioned.

#### **Facilities**

Our facilities include two well-equipped skills labs with 16 hospital beds and modern examination rooms, both of which provide students with hands-on opportunities to practice skills prior to entering clinical sites. Also available are three simulation rooms, which are equipped with adult and child high-fidelity human patient simulators. Students also have access to state-of-the-art simulation facilities at partnering agencies. These resources provide students with experiences in lifelike scenarios of a variety of patient care situations.

# **Admission Requirements**

Candidates entering the nursing program through direct admission need a minimum 3.0 cumulative high school GPA, successful completion of two high school laboratory science courses and math through Algebra 2. Transfer students must have a minimum weighted cumulative 3.0 GPA and a minimum 2.75 GPA for science courses, which must have been completed within the last 5 years. Courses completed by transferring students must be from a regionally accredited college(s) or university(ies). Additionally, transfer students currently enrolled in a nursing program must provide a letter of recommendation from their current program administrator.
